INTERGROUP – Sharon P.

- ❖ Rochelle B. moved up to Chairperson for the remainder of the term. Leslie was elected to Vice-Chairperson. The Board is looking into possibly having credit card sales available at the bookstore. Cost of goods sold vs gross profit is more in line this month due to the large volume of Big Books sold. Group contributions are \$500 under expected budget. The A.A. Intergroup Office Web-site gets on average, 400-500 hits per day. Volunteers are needed in the Office on Mondays, Wednesdays, and Thursdays. All night watch slots are covered at this time. Correctional Committee meets 3rd Monday of each month at 8:00 PM, at the Intergroup Office. The Houston A.A. Intergroup Office matches every \$15.00 donation toward the purchase of Grapevine Subscription for the inmates. Jack B. told the history of the Avalon Happy Hour Group, started in 1981. Jerry L. continued his presentation on Service in Alcoholics Anonymous. Service work is about focusing on the Alcoholic that still suffers and the responsibility of the recovering alcoholic to help those who are still suffering. That's why it is important for us to stay linked up from, Member to Group, to Intergroup and District, to Area, to the Region and to G.S.O. (World). The question was asked if could the Book Store sell the Big Book at cost? It was noted that at one time the Big Book was sold at below cost when Group contributions were up, but with Group contributions so far down it is necessary for the Intergroup Office to have a mark up to keep sufficient operating funds. (Remember at the last meeting it was noted that Intergroup only receives 14% of the need money for it's

operation from Group donations, 83% comes from the Bookstore sales.) Roy reported that the Big Book and the 12&12 are the two biggest sellers. The budget committee will look into a Big Book price adjustment and report back at the next meeting. *Next Meeting October 18th 8:00 PM*
