RIGIDITY IN A.A.

During my first three years sober, I introduced myself loudly as a DOPE FIEND and an alcoholic. Some of the longer-term members of my group would scowl and snap at me to quit being an "and a". I would throw pennies across the room, get up and down several times, engage in side conversations during the meetings, dress inappropriately, etc. etc. Shockingly enough, I wasn't kicked out of AA. Over time, I learned through working the steps and practicing spiritual principles in small bites, to change my conduct. I started becoming a huge fan of AA customs and tradition. It is awful to admit that I have been guilty of being so ego driven and have actually caught myself parroting insults in a group meeting that I heard from some of our crusty oldtimers.

This behavior didn't start straight out of the gate, but as I started gaining confidence in what "I thought I knew," I became more arrogant and intolerant.

Now as the years roll on, I cringe at some of the mandates I hear in meetings. Someone will yell out, "You can't talk about that in this meeting!" if one member has the audacity to mention something like smoking weed in their share, or commit any number of supposed AA cultural infractions.

I once read the printout of a farewell speech given by Bob Pearson.


Bob Pearson (1917-2008) was General Manager of the General Service Office from 1974 to 1984, and then served as Senior Advisor to the G.S.O. from 1985 until his retirement. His story is in the Big Book as "AA Taught Him to Handle Sobriety." During the 1986 General Service Conference, Bob gave a powerful and inspiring closing talk to the conference at the closing brunch on Saturday morning, April 26. Here is a small excerpt:

"If you were to ask me what is the greatest danger facing AA today, I would have to answer: the growing *rigidity* – the increasing demand for absolute answers to nit-picking questions; pressure for GSO to "enforce" our Traditions; screening alcoholics at closed meetings; prohibiting non-Conference-approved literature, i.e., "banning books;" laying more and more rules on groups and members. And in this trend toward rigidity, we are drifting farther and farther away from our co-founders. Bill, in particular, must be spinning in his grave, for he was perhaps the most permissive person I ever met. One of his favorite sayings was, "Every group has the right to be wrong." He was maddeningly tolerant of his critics, and he had absolute faith that faults in AA were self-correcting."

What I am learning slowly over time is to give grace: allow the newer members to find their footing, to become acclimated to our group cultures, to have quiet conversations after the meetings, to have animated discussions with my sponsees and friends, to make AA a safe place for people to come, get sober, and become productive family members and citizens.

I don't think anyone likes to be yelled at or shamed in a group. Imagine what that would feel like or even being a witness to that behavior when you were brand new.

We are in the life-saving business. AAs everywhere learn to support each other's recovery and growth. I hope I will stay mindful and encourage people to keep coming back so that they can fall madly, deeply in love with Alcoholics Anonymous.

A Poison Tree By William Blake

I was angry with my friend:
I told my wrath, my wrath did end.
I was angry with my foe:
I told it not, my wrath did grow.

And I watered it in fears
Night and morning with my tears,
And I sunned it with smiles
And with soft deceitful wiles.

And it grew both day and night, Till it bore an apple bright, And my foe beheld it shine, And he knew that it was mine,

And into my garden stole
When the night had veiled the pole;
In the morning, glad, I see
My foe outstretched beneath the tree.

When I read this poem, I am struck by the beautiful language. As a recovering alcoholic, I can relate this poem to the power I can give my disease at times, when I keep my thoughts and feelings to myself. It can be easy to resolve conflicts with a "friend" as the author references. But what about those difficult

conversations with people I don't like or don't want to hurt by speaking my truth? What about the negative thoughts and feelings that creep in slowly over time when things don't go my way? What about the quiet voice that says maybe I could take just one drink? I can usually brush them off for a while, but over time if I do not share about my true thoughts and feelings with my sponsor or my home group, I will begin to have a wrath that grows and that is watered in fears. Today I can ask my Higher Power for the strength to pick up the phone or go to a meeting and speak my truth no matter how painful or embarrassing it may be. God will never let us down.

A BRIEF HISTORY OF DISTRICT 81

According to my sponsor Bill B., District 8 was divided into 3 different areas, East, Central, and West. They held district meetings at Alvin Taylor Street. I didn't participate in any of those meetings, but I attended one meeting with a guy that I sponsored. That was in 1997 when I was 5 years sober.

In January of 2013, our district became District 81 and Alvin became District 82. District 81 decided to move to Kelley's in La Marque and Bonita W. was the DCM. I became GSR of the New Day Group and I eventually became the D81 Intergroup Representative. My job was to attend the Houston Intergroup meetings that were held every other month in Houston. The various committees were pretty much the same as they are today. The difference was that the Public Information chair would attend the SETA meetings and would report back to the district what was happening in the area. Same with CFC. Archives, CPC, Literature, Grapevine, etc. This was kind of the process up until early 2007.

Enter a member by the name of Parth M. our new DCM. Parth made an announcement that everyone chooses a committee and start attending that committee meeting. In other words, we were going to start doing the committee at the district level. That's when District 81 became very active. Besides the monthly district meeting at Kelley's, a lot of our membership joined the various committees and started doing the work at the district level. This changed the whole atmosphere of our district and brought additional members into service work.

For example, the TFC committee is still busy carrying the message into treatment facilities, PI stays busy with PSAs, furnishing

literature racks to about 15 different locations. CFC taking meetings into Carol Young prison unit and meetings into Galveston County Jail, Grapevine having monthly meetings to promote the sale of their magazine, Archives committee holding meetings to preserve the history of AA, our tech committee has set up a website and what an excellent job they have done. Our district newsletter is probably the best in the area. I could go on and on what each committee does, but I think you get the picture.

Besides all the committee work that we do, we have members that have gone down the service structure and are active in SETA.

I realize that this is a thumb nail sketch of District 81 but when you get to be my age, it's a miracle that I could remember as much as I have.

God Bless all of you guys and gals and thanks for making District 81 what it is today.
