

WWWW Some Group Histories of District 81

Over the recent years, I have submitted group histories to the SETA Newsletter of Galveston Island, Texas City, and Santa Fe. Below are a few other group histories of some of our groups in District 81.

The West Isle Group of Galveston was started in September of 1973 by Milt S. and K.B.W. Meetings were closed discussion and were held at St. Peter's Catholic Church, 1804 69 th St. off Heard's Lane at 8:00PM on Fridays. Later, a step study meeting was added to their schedule, and they met at Milt's house at 8:00 pm on Wednesdays. A Big Book study meeting was added to the schedule on Monday night. The group later moved to Our Lady of Guadalupe Church at 45 th and Ave L, and eventually moved later to its present location, which is Zion Lutheran Church at 6910 Yucca. Zion Lutheran Church was heavily damaged from Hurricane Ike but is back in business and the group meets at 7:00 pm on Mondays and Wednesdays, at 8:00 pm on Tuesdays, Thursdays, and Fridays. Since the Covid pandemic, they are currently meeting on Mondays and Fridays at 7:00 pm at the Westminster Presbyterian Church located at 5127 Ave U.

Jamaica Beach Group was founded in 1977 by Joe and Annie. Other early members were Mitzi, Mike, Tom, and Jack. The group met at Joe and Annie's house in Jamaica Beach for about one year and eventually moved to the present location, which is West Isle Presbyterian Church (Pirates Beach) on Stewart Road. Jamaica Beach meetings are open discussion and are at 7:30 pm on Mondays and Thursdays. Birthday meeting is last Thursday of the month. Both meetings are nonsmoking.

REBOS Group (sober spelled backwards) of Pearland was founded in January of 1985. Founders and early members were Alfred K., Jane K., Mary F., Marty R., Trudy R., Dede W., and Rita K. REBOS group meets at St. Helens Catholic Church at 8:00 pm on Fridays. Meetings are open discussion and there is a tradition of the members going to Kelley's in Pearland for a late dinner after the meeting.

Pearland BB/SNL was founded in October of 1997 by Carlos R. Early members besides Carlos were George M., Jack B., Ronald P., Ron S., Karen, Norma, Johnny B., and Jim. Group meets at St. Andrews Episcopal Church in Pearland. The Tuesday night meeting at 7:30 pm is a Big Book Step Study format. The Saturday Night Live is at 7:30 pm on (you guessed it) Saturday night and is an open discussion meeting.

Please note that some of the meeting times and locations have changed due to the Covid pandemic.





On behalf of the employees at the General Service Office (G.S.O.), I wish you a very Happy New Year! While we A.A.s strive to live one day at a time, for many still, the new year brings a spirit of renewal and an added spark of hope. I share this spirit, particularly for the future of A.A.

I am pleased to share some exciting updates and changes at G.S.O. G.S.O. provides a tremendous range of critical services, which requires that the office be structured in the best way possible to facilitate the delivery of these services efficiently and effectively. At the same time, we must stay true to the spiritual principles that guide our work. With this in mind, we have taken a close look at several services and functions and made some changes.

Many of these changes are in the Publishing Department, which produces, distributes, and updates our life-saving literature. As the world has changed, many of these services have grown in complexity-specifically, the licensing of our literature to A.A. structures around the world, new translations of our books and pamphlets, translation of documents and background for our General Service Conference, and monitoring and protecting Intellectual Property Rights related to our literature and the A.A. name. These services are vital, not only in assisting groups and members in carrying the message, but also to preserve our single purpose and our Traditions.

The primary reason for these changes is to allow for more focus on and oversight of these services, and to allow the Publishing Department to focus directly on our literature. To best facilitate carrying out these and the other services in the most effective manner, we have established two separate departments.

Legal, Licensing and Intellectual Property. In addition to assuming the services of international literature licensing and Intellectual Property (IP), this new department has assumed the responsibility for coordinating all legal matters administered at G.S.O. This department is staffed by leadership with strong legal background and others with deep experience in licensing and IP.

Language Services. As I mentioned in my most recent communication, this department has centralized the function of translation of our literature and thousands of documents into several languages each year. It also coordinates essential interpretation services that allow for direct interaction and communication with other A.A. structures around the world. These services ensure full participation and help to unify our worldwide Fellowship.

These changes are the result of a great deal of collaboration, participation, and effort by members of management and their teams. All involved have been very open and willing to make this happen and are enthusiastic about increasing the effectiveness of the office and our services. These efforts are another example how we infuse our principles into the G.S.O. operations.

We are here to serve the Fellowship and are grateful for your support through your contributions to the General Service Board and the trust you place in us and each other.
